The Law Department of HPPCL is independently engaged in defending various court cases being filed against Corporation in Hon'ble Supreme Court, Hon'ble High Court, National Green Tribunal and in various other Civil Courts. In order to provide proper & timely legal assistance by a qualified/experienced legal luminary at level of Sr. Law Officer/Law Officer shall be of immense assistance to the management of HPPCL, in dealing, coordinating & liaising various cases in legal Cell of HPPCL and the post is required to be filled up urgently.

The qualification requirements for the post of Law Officer/Sr. Law Officer shall be **"Full time Graduate degree in Law from a recognised University/Institute with minimum of 2 years of experience in the immediate lower level grade/scale/post"**.

The candidate finalised for the aforesaid post shall be governed under terms & conditions as per normal policy of GoHP, on Secondment, however shall be entitled to additional few allowances, at par with other seconded employees working in HPPCL. The level /equivalence will be given depending upon the experience possessed by the officials.

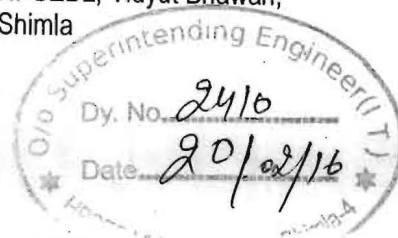
