

Subject : Inviting applications/ nominations for the post of Chairperson, CERC

The Central Electricity Regulatory Commission (CERC) was set up by the Government of India at New Delhi under the provisions of the erstwhile Electricity Regulatory Commissions Act, 1998. CERC is deemed to have been constituted under the corresponding provisions of the Electricity Act, 2003 which repealed the Electricity Regulatory Commission Act, 1998. The Commission consists of the Chairperson and three other Members (and also Chairperson, Central Electricity Authority as ex-officio Member of the Commission). **The post of Chairperson, CERC will fall vacant on 20.12.2017.** It is proposed to fill up the anticipated vacancy.

2. Appointment to the posts of Chairperson, CERC is governed by the relevant provisions of the Electricity Act and the Central Electricity Regulatory Commission (Salaries, Allowances and other Conditions of Service of Chairperson and Members) Rules, 2004 as amended from time to time. Chairperson, CERC is presently entitled to a consolidated pay of Rs.4.50 lakh per month (without house and car).

3. Section 77(1) of the Electricity Act, inter-alia, states that the Chairperson and the Members of the CERC shall be persons having adequate knowledge of, or experience in, or shown capacity in, dealing with, problems relating to engineering, law, economics, commerce, finance or management. The above anticipated vacancy of Chairperson, CERC is required to be filled up from the fields of economics, law or management. In terms of section 89 of the Act, the Chairperson shall hold office for a term of five years from the date on which he/ she enters upon his/ her office or till he/ she attains the age of sixty-five years, whichever is earlier. The candidate is required to give a declaration that he/she does not have any financial or other interest, which is likely to affect prejudicially his/her function as Chairperson, CERC.

4. Relevant extracts of the Electricity Act, 2003 relating to the requirement of qualification, experience, etc. for Chairperson, CERC and copy of Central Electricity Regulatory Commission (Salaries, Allowances and other Conditions of Service of Chairperson and Members) Rules, 2004, Amendment Rules of 2010 and format of the declaration mentioned in para 3 are available at Ministry's website www.powermin.nic.in and the website of DoPT www.persmin.nic.in.
