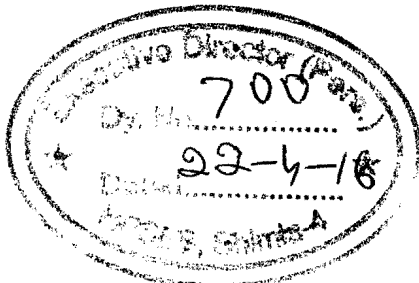

- (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in the scale of pay of Rs. 12,000-16,500/- (Pre revised)/ (Revised) PB-3 Rs.15,600-39,100/- + Grade Pay Rs. 7,600/-

or equivalent in the parent cadre or Department ; or

- (iii) with ten years' service in the grade rendered after appointment thereto on a regular basis in posts in the scale of pay of Rs.10000-15200/-(Pre revised)/ (Revised)PB-3 Rs.15,600-39,100/- + GP Rs.6,600/- or equivalent in the parent cadre or Department ; and

(b) possessing the following educational qualifications and experience :

- (i) Bachelor's Degree in Civil Engineering from a recognized University or Institute or equivalent.
- (ii) Twelve year's experience in execution or construction of civil works including hill roads.

- 2. The departmental Executive Engineer (Civil) with ten years' regular service in the grade shall also be considered alongwith outsiders and in case he is selected for appointment to the post the same shall be deemed to have been filled by promotion.

Note 1 :- The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.

Note 2:- Period of deputation or contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.

The candidate who applied for the post would not be allowed to withdraw their candidature subsequently.

To assist Adviser (Transport & Communication), NEC in all matters pertaining to Transport and Communication sector including the Road and Bridge schemes/ projects undertaken by Transport and Communication sector under the guidance of Adviser (T&C) and to give all necessary inputs to Adviser(T&C) so that he can advise Secretary, NEC in all matters pertaining to Transport and Communication sector.
