

This is a case where the government in the case of blind person has declined to grant any relaxation for regularization in the post of Tabla Instructor, despite pointing out another case. Put up with the writ records in CWP(T) No. 6702 of 2008.

2. There shall be no relaxation in the case of any person either for employment or for promotion or for regularization either in terms of the age or in terms of the qualification or in terms of the eligibility until further orders.

3. There shall also be a direction to the respondent to make available the entire records pertaining to the consideration of the case of the petitioner for relaxation on the next date of hearing.
