OFFICE MEMORANDUM

Subject: Fixation of pay of re-employed pensioners--amendments regarding.

The undersigned is directed to refer to this department's office memoranda No. FinOB(7)10/84 dated 1st December, 1988 and FinOB(7)10/98 dated 8<sup>th</sup> September, 1999 on the above cited subject and to say that consequent upon the revision of pay scales of the employees w.e.f. 1.1.2006, the Governor, Himachal Pradesh is pleased to enhance the existing upper limit for drawal of pay plus gross pension, on reemployment, from Rs.26000/- to Rs.80000/-.

2. The undersigned is further directed to say that the Governor, Himachal Pradesh is pleased to order the enhancement in the ignorable part of pension from Rs.1500/- to Rs.4000/- in the revised pay scale in case of service officers of defence forces and civil officers holding class-I posts who retire before attaining the age of 50 years, on their reemployment.

3. The emoluments in the case of those who were on re-employment before 1.1.2006 and who continued as such ever after 1st January 2006, shall be determined as Basic Pay last drawn immediately before retirement plus Dearness Pay plus Interim relief, if any, admissible at the time of retirement plus Dearness allowance admissible at the time of retirement.

4. The Governor, HP is also pleased to order that para -12 of the OM dated 1.12.1988, *ibid*, shall stand deleted and para -13 of this OM, shall be amended as under:-

"13. The provisions of CCS (Leave) Rules, 1972 shall not be applicable to the reemployed pensioner and he will also not be entitled to LTC facility. He/she will be entitled to one casual leave for each completed month."

5. The amendments with regard to para 2 and 13 of the OM dated 12.12.1988, ibid, shall come into force prospectively, whereas, other amendments shall be effective from 1.1.2006. The Annexure-I to the OM dated 12.12.1988 ibid, shall also be deemed to have been modified to this extent.

6. The other terms and conditions shall be the same as circulated earlier.


