Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Ltd. Pensioners/Family Pension-Revised rate effective from 01.01.2015.

In continuation to the office order No. HPSEB (SECTT(R&E/6/156/2014-80366-586 dated 17.03.2015, the Himachal Pradesh State Electricity Board Ltd. Is pleased to decide that the dearness relief payable to HPSEBL, Pensioners/Family Pensioners shall be enhanced from the existing rate of 107% to 113% w.e.f. 01.01.2015 on the following terms and conditions:-

1. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off the next higher rupee.
2. Other Provisions governing grant of Dearness Relief to pensioners such as regulation of Dearness Relief during employment/-re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
3. These orders shall apply to all the pensioners/Family Pensioners of the HPSEB Ltd.
4. As Dearness Relief is at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner along with these orders. It will be the responsibility of the pension disbursing authority, including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
5. The Chief Accounts Officer, Drawing & Disbursing Officer & the authorized Public Sector Banks are requested to arrange payment of Dearness Relief to pensioners on the basis of these orders.
6. The enhanced Dearness Relief on pension & Family Pension @ 113% will be paid with the pension/Family pension for the Month of October, 2015 payable in the month of November, 2015. The arrears accrued on account of dearness relief w.e.f. 01.01.2015 to 30.09.2015 shall be paid in cash in one instalment with the pension of October, 2015 payable in the month of November, 2015.
