OFFICE MEMORANDUM

**Subject: - Grant of Pension Allowance.**

In partial modification to this Department's Office Memorandum No. Fin (Pen)A(3)-1/09- dated 23<sup>rd</sup> April, 2014, the undersigned is directed to say that Governor. Himachal Pradesh is pleased to order that Pension Allowance @5%,10% and 15% as the case may be, on attaining the age of 65 years, 70 years and 75 years respectively shall be admissible only on one pension i.e. either on basic Pension or basic Family Pension, whichever is higher. to Govt. pensioners who are getting two pensions i.e. both Pension and Family Pension, from Government. This order would also be applicable to All India Service pensioners of H.P. Cadre. This order shall take effect from 1-1-2015.
