The Himachal Pradesh State Electricity Board Limited is pleased to release the arrear of revised grade pay (w.e.f. 1.10.2012 to 30.9.2014) revised vide this office order No. 4 /HPSEBL (Sectt)/2014 dated 1.11.2014 endst. No. HPSEBL/(Sectt)/Scale-1 (Regulation) /2014-44659-879 dated 1.11.2014 further office order No. 12 dated 4.7.2015 endst. No. HPSEBL (Sectt) Scale-1/ (Regulation)/2015-30895-31115 dated 4.7.2015 and office order No. 14 dated 4.7.2015 endst. No. HPSEBL (SECTT)/SA/Scale-1/ (Regulation) /2015-31337-557 dated 4.7.2015 in two equal installments to be credited to the GPF accounts of the employees. The 1st installment of arrear will be credited to the GPF accounts of the employees with the salary for the month of June, 2016 payable in July, 2016 and 2nd installment shall be released with the salary for the month of December, 2016 payable in January, 2017.

However, in case of employees who are members of National Pension System or who have retired from the services of the Board Ltd. the arrear shall be paid in cash in two installments as above.

The recoverable amount, if any, may be adjusted from the above arrear and only net amount may be paid after deducting the income tax which ever applicable.

In case of HPSEB Ltd. employees, who during the period w.e.f. 1.10.2012 to 30.9.2014 worked in different Government Departments or PSUs/Boards/ Corporations/ of the Government etc., the arrear may be prepared and disbursed by the concerned State Govt. Department or PSUs/Board/Corporation etc. where such employees are presently working.
