Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Ltd. Pensioners/ Family Pensioners -- Revised rate effective from 01-01-2014.

In continuation to this office order No. HPSEB (SECTT)/R&E/6-156/2014- 87519-670 dated 4-03-2014, the Himachal Pradesh State Electricity Board Ltd., is pleased to decide that the dearness relief payable to HPSEBL Pensioners/ Family Pensioners shall be enhanced from the existing rate of 90% to 100% w.e.f. 01-01-2014 on the following terms and conditions:-

1. Payment of Dearness Relief involving a fraction of rupee shall be rounded off to the next higher rupee.
2. Other provisions governing grant of Dearness Relief to Pensioners such as regulation of Dearness Relief during employment/ re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
3. These Orders shall apply to all the Pensioners/ Family Pensioners of the HPSEB Limited.
4. As Dearness Relief is at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith dearness relief orders. It will be the responsibility of the pension disbursing authority, including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
5. The Chief Accounts Officer, Drawing Disbursing Officer(s) & the authorized Public Sector Banks are requested to arrange payment of Dearness Relief to pensioners on the basis of these orders.
6. The enhanced Dearness Relief on pension & family pension @ 100% will be paid with the pension/family pension for the month of October, 2014 payable in the month of November 2014. The arrears accrued on account of dearness relief w.e.f. 01.01.2014 to 30.09.2014 shall be paid in the month of November 2014.
