1. <u>Pre-1.1.2006 Pensioners/Family Pensioners</u>	
1. On consolidation of Pension/Family Pension made by Banks/by this office.	(a) Consolidated Pension/Family pension be paid from 1.1.2010 onwards alongwith Dearness Relief @27%.

		(b) The arrear of Dearness Relief in Pension/Family Pension @6% w.e.f.1.1.2009 to 30.6.2009 and 6%+5%(Total 11%) from 1.7.2009 to 31.12.2009 may also be released.
2.	<u>Post- 2006 Pensioners/Family Pensioners.</u>	
(a)	In case where Pension/Family Pension has been revised.	(a) Revised Pension/Family Pension be paid from 1.1.2010 with 27% Dearness Relief in Pension/Family Pension. (b) The arrear of Dearness Relief in Pension/Family Pension @ 6% w.e.f.1.1.2009 to 30.6.2009 & 5% (Total 11%) from 1.7.2009 to 31.12.09 may also be paid as from actual date of retirement or whichever is later.
(b)	In case where Pension/Family Pension has not been revised.	Dearness Relief in Pension/Family Pension be paid @ 6% from 1.1.2009 & 5% w.e.f. 1.7.2009 (Total 11%) onwards on the same emoluments on which 54% is being paid until revision of Pension or change in Dearness Relief.

It is, therefore, requested suitable directions/instructions to implement the orders issued by the HPSEB LTD. may be imparted to the Paying Bank Branches to avoid financial hardship to the Pensioners/Family Pensioners.
