Office Order


In partial modification to this office order endorsement No. HPSEB (Sectt)/ R&E 154-1/2011-116083-125 dated 28/1/2012, it has further been decided that the Proviso as prescribed for addition at the end of FR-116, may be substituted as under:-

"Provided that the rates of contribution for Pension and Leave Salary as contained in Appendix-II to FR shall be increased by 50% in case of Officers/ Officials on Deputation/Foreign Service/ Secondment for the period beyond 3 years but below 5 years.

Provided further that these rates will be increased by 75% for the period of Deputation/Foreign Service/ Secondment exceeding 5 years but below 7 years and by 100% in case the said period exceeds 7 years.

The orders will be applicable with immediate effect.


