



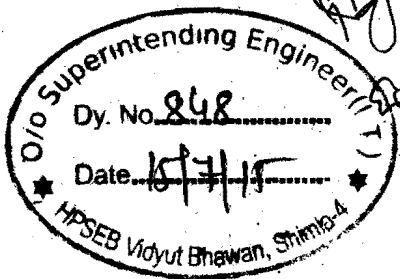
The Himachal Pradesh State Electricity Board Limited is pleased to amend the provision contained in Column No.10 of the R&P Regulations to the post of Assistant Accounts officer notified vide notification No. HPSEB (SECTT)/106-10/2006-74758-958 dated 1.11.2006 and further amended from time to time with latest notification No.HPSEB (SECTT) /R&E/106-10/2009-94421-621 dated 2.1.2010.

Assistant Accounts Officer (Column No.10)

Existing provisions	Amended provisions
i) 20% appointments by method of direct recruitment having qualification M.Com/MBA (Finance).	i) No change.
ii) 60% from amongst the Superintendent (D/A) who pass Part-II of SAS Examination and possesses 3 years service as Supdt. (D/A) is eligible for promotion as Assistant Accounts Officer.	ii) 80% from amongst the Superintendent (D/A) who pass Part-II of SAS Examination and possesses 3 years service as Supdt. (D/A).
iii) 20% by promotion from DA with five years service as D.A. who appeared in SAS Part-II examination three times or more and secured 33% aggregate marks at least in two chances provided that this provision will be applicable after two years of notification of these amendments so that opportunities for writing three examinations for SAS Part-II is available to the feeder category incumbents. Provided further that the condition of appearing in examination shall not be applicable for the incumbents who have attained the age of 55 years and above for promotion during this intervening period of two years.
